Official Rules

NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

- 1. Eligibility: The Children's Place New Store Grand Opening Sweepstakes (the "Sweepstakes") is open only to legal residents of the fifty (50) United States (and the District of Columbia) and Canada (excluding Quebec), who are at least eighteen (18) years old at the time of entry. Void in Quebec and where prohibited by law. Employees of The Children's Place Retail Stores, Inc., ePrize, LLC, and their parent and affiliate companies as well as the immediate family (spouse, parents, siblings and children) and household members of each such employee are not eligible. Subject to all applicable federal, state, provincial, municipal, territorial and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's and Administrator's decisions, which are final and binding in all matters related to the Sweepstakes. Timing:** The Sweepstakes begins when the New Store Grand Opening for a Children's Place Retail store begins, and ends at the close of business, for that Children's Place Retail store, two (2) weeks from the date of the Grand Opening (the "Promotion Period"). Store register's clock is the official time-keeping device for the Sweepstakes.
- 4. How to Enter: a. Make a Purchase: During the Promotion Period, visit the new Children's Place Retail store within two (2) weeks of the New Store Grand Opening and make a purchase a credit or debit card. At checkout, you will be asked if you would like to enter the Sweepstakes. If you would like to enter the Sweepstakes, you will receive one (1) Sweepstakes entry. b. Free Method of Entry: To enter without making a purchase (or after making a purchase without a credit or debit card), visit the new Children's Place Retail store within two (2) weeks of the New Store Grand Opening and locate the official entry forms. Fill out the form completely and deposit it into the designated receptacle. All entries become the exclusive property of Sponsor, and none will be acknowledged or returned. Proof of submission will not be deemed to be proof of receipt by Sponsor. Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible, illegible, or misdirected entries, which will be disqualified. Limit: Each participant may enter one (1) time during the Promotion Period, regardless of method of entry. Multiple entrants are not permitted to share the same email address. Any attempt by any entrant to obtain more than the stated number of entries by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entrant's entries and that entrant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification.
- 5. Grand Prize Drawing: Potential winner must continue to comply with all terms and conditions of these Official Rules; and winning is contingent upon fulfilling all requirements. Administrator is an independent judging organization, whose decisions as to the administration and operation of the Sweepstakes and the selection of the potential winner are final and binding in all matters related to the Sweepstakes. Administrator will randomly select the potential Sweepstakes winner from all eligible entries received during the Promotion Period, approximately one (1) calendar month following the conclusion of the Promotion Period. The potential winner will be notified by mail, email or phone. If the potential winner is a Canadian resident, he/she will be required to answer a time limited skill testing question without assistance, in order to be eligible to receive a prize. If the potential winner cannot be contacted, fails to answer the skill-testing question correctly (if applicable), or prize is returned as undeliverable, potential winner forfeits prize. In the event that the potential winner is disqualified for any reason, Sponsor will award the prize to an alternate winner by random drawing from among all remaining eligible entries. Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of these Official Rules or any other Promotion or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.
- 10.
