1. Eligibility: Win Big. Go Paperless. Sweepstakes (the "Sweepstakes") is open only to US Persons, including Resident Aliens, of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years old and have one (1) or more of the Retail Services Card accounts listed below issued by Citibank, N.A. on or before October 1, 2013 (each a "Retail Services Card"). Retail Service Card must be in good standing at time of entry and prize fulfillment.

Employees of Citicorp Credit Services, Inc. (USA) ("Sponsor"), Citibank, N.A., Spiral Design Studio, LLC, EXACTTARGET, INC., Razorfish LLC, ePrize, Inc., and their parent and affiliate companies as well as the immediate family (spouse, parents, siblings and children) and household members of each such employee are not eligible. The Sweepstakes is subject to all applicable federal, state, and local laws and regulations and is void in Puerto Rico, Guam and the U.S. Virgin Islands and where prohibited. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's and Administrator's decisions, which are final and binding in all matters related to the Sweepstakes. - **3. Timing:** The Sweepstakes begins on October 20, 2013 at 12:00 a.m. Eastern Time ("ET") and ends on December 31, 2013 at 11:59 p.m. ET (the "Promotion Period"). Sponsor's computer is the official time-keeping device for the Sweepstakes.
- **4. How to Enter:** There are two (2) ways to enter during the Promotion Period.
 - **a. Enter by enrolling in Paperless Statements and/or Paperless Letter:** During the Promotion Period, log into your applicable online Retail Services Card account. If

you don't already have access to your Retail Services Card account online, you may register and create an account. Creating this online account is free, but is subject to listed terms and conditions. Follow the links and instructions to register and enroll your Retail Services Card in Paperless Statements and/or Paperless Letters. You automatically will receive one (1) entry into the Sweepstakes for enrolling in Paperless Statements and you will receive one (1) entry into the Sweepstakes for enrolling in Paperless Letters. Limit: Each member may receive up to two (2) entries into the Sweepstakes for each applicable Retail Services Card for which he/she holds during the Promotion Period.

b. Enter if you are currently enrolled in Paperless Statements and/or Paperless Letters: To enter if you are already enrolled in Paperless Statements and/or Paperless Letters, hand print your name, address, day and evening phone numbers, email address, and date of birth on a 3" x 5" piece of paper and mail it in an envelope with proper postage to "Win Big. Limit: You may mail in up to two (2) envelopes for each of your Retail Services Card Accounts. All mail-in entries must be handwritten and must be postmarked by December 31, 2013 and received by January 7, 2014. All entries become the exclusive property of Sponsor and none will be acknowledged or returned. Proof of sending or submission will not be deemed to be proof of receipt by Sponsor. Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible, illegible, misdirected or postage-due entries, which will be disqualified.

Limit: Each entrant may receive up to two (2) entries per Retail Services Card account held during the Promotion Period. For each Retail Services Card account, only the primary Retail Services Card holder of the Retail Services Card account will receive the entry regardless of who actually enrolled in the Paperless Statements and/or Paperless Letters service. In the event the Retail Services Card account is a joint account, the individual who enrolled in the applicable paperless service will receive the entry into the Sweepstakes.

Any attempt by any entrant to obtain more than the stated number of entries by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entrant's entries and that entrant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. In the event of a dispute as to any registration, the authorized account holder of the email address used to register will be deemed to be the entrant. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Each potential winner may be required to show proof of being the authorized account holder.

5. Grand Prize Drawing: Administrator is an independent judging organization whose decisions as to the administration and operation of the Sweepstakes and the selection of the potential winners are final and binding in all matters related to the Sweepstakes. Administrator will randomly select the potential Sweepstakes winners from all eligible entries received during the Promotion Period, on or around January 31, 2014. The potential winners will be notified by email or phone. Except where prohibited, each potential winner (parent/legal guardian if a winner is a minor in his/her place of residence) will be required to sign and return an Affidavit of Eligibility, Liability & Publicity Release ("Affidavit") and a IRS form W-9, which must be received by Sponsor within seven (7) days of the date notice or attempted notice is sent, in order to claim his/her prize. Winners will receive a Form 1099-MISC, and the value of the prize will be reported to the IRS as income in the year received, if the value of the prize plus other taxable miscellaneous income awards received from Citicorp Credit Services, Inc. Sponsor reserves the right, in its sole discretion, to disqualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of the Official Rules of this or any other promotion or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.
- **10. Limitations of Liability:** The Released Parties are not responsible for: (1) any incorrect or inaccurate information, whether caused by entrants, printing errors or by any of

the equipment or programming associated with or utilized in the Sweepstakes; (2) technical failures of any kind, including, but not limited to malfunctions, interruptions, or disconnections in phone lines or network hardware or software; (3) unauthorized human intervention in any part of the entry process or the Sweepstakes; (4) technical or human error which may occur in the administration of the Sweepstakes or the processing of entries; (5) late, lost, undeliverable, damaged or stolen mail; or (6) any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Sweepstakes or receipt or use or misuse of any prize. In the event that production, technical, seeding, programming or any other reasons cause more than the stated number of prizes as set forth in these Official Rules to be available and/or claimed, Sponsor reserves the right to award only the stated number of prizes by a random drawing among all legitimate, un-awarded, eligible prize claims.

Disputes: Except where prohibited, entrant agrees that: (1) any and all disputes, claims and causes of action arising out of or connected with this Sweepstakes or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the United States District Court for the Eastern District of Michigan (Southern Division) or the appropriate Michigan State Court located in Oakland County, Michigan; (2) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Sweepstakes, but in no event attorneys' fees; and (3) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim, indirect, punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased.
