Feline Fashion Friday Contest OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN.

- **1. Eligibility:** Feline Fashion Friday Contest (the "Contest") is open only to legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years old at the time of entry.
