## Hidden Valley Royal Ranch Sweepstakes Official Rules

- 1. Eligibility: Hidden Valley Royal Ranch Sweepstakes (the "Sweepstakes") is open only to legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years old at the time of entry.
