Coca-Cola & Regal Star Trek Beyond Sweepstakes

Official Rules

NO PURCHASE REQUIRED TO ENTER OR WIN.

- 1. Eligibility: The Coca-Cola & Regal *Star Trek Beyond* Sweepstakes (the "Sweepstakes") is open only to legal residents of the 50 U.S. (or D.C.) who are 13 years of age or older at the time of entry.  - b) <u>Mail-In Alternate Method of Entry</u>: During the Promotion Period, to enter without making a purchase, hand print your full name, street address, (no P.O. Boxes), day/evening/cellular phone number (if any), email address and date of birth on a 3" x 5" piece of paper and mail it in an envelope with proper postage to "Coca-Cola & Regal *Star Trek Beyond* Sweepstakes Sweeps Entry," P.O. Box 5018, Department 826602, Kalamazoo, MI 49003-5018. You will receive **1 entry into the Sweepstakes**. Limit: 1 entry per stamped envelope. All mail-in entries must be handwritten, postmarked by July 22, 2016 and received by July 29, 2016. All entries become the exclusive property of Sponsor and none will be acknowledged or returned. Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible, illegible, misdirected or postage-due entries, which will be disqualified.

<u>Limit</u>: 1 Sweepstakes entry per person during the Promotion Period, regardless of method or combination of methods of entry. Multiple entrants are not permitted to share the same email address. The potential winners will be notified by email, mail or phone.
