## Smashburger Smash Pass™ Sweepstakes

## Official Rules

NO PURCHASE REQUIRED TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. SMASH PASS™ REQUIRED TO ENTER VIA ONE METHOD. VOID WHERE PROHIBITED BY LAW.

- 1. Eligibility: The Smashburger Smash Pass™ Sweepstakes (the "Sweepstakes") is open only to legal residents of the 50 United States (or the District of Columbia) who are 21 years of age or older at the time of entry. Employees and non-employee workers of Smashburger Servicing LLC, The Coca-Cola Company, Coca-Cola bottlers, HelloWorld, Inc., and their respective parent companies, subsidiaries, affiliates, and agents and those prize providers and agencies that are involved in the development or execution of this Sweepstakes or any of its materials, and the immediate family (spouse, parents, siblings, and children) and household members of each such person are not eligible. - **3. Agreement to Official Rules:** By participating in the Sweepstakes, entrant fully and unconditionally agrees to and accepts these Official Rules and the decisions of the Sponsor and Administrator, which are final and binding in all matters related to the Sweepstakes.
- **4. Promotion Period:** The Sweepstakes begins at 12:00 a.m. Eastern Time ("ET"), November 5, 2018 and ends at 11:59 p.m. ET, February 14, 2019 (the "Promotion Period"). Smashburger Servicing LLC's computer is the official time-keeping device for this Sweepstakes.
- **5. How to Enter:** There are 2 ways to enter:
  - a. Purchase a Coca-Cola Beverage Using your Smash Pass™: During the Promotion Period, visit a participating Smashburger restaurant and purchase any size Coca-Cola beverage when using your Smash Pass™. If you make a qualifying purchase and use your Smash Pass™, you automatically will receive 1 entry into the Sweepstakes per transaction, up to the limit stated below.

<u>Sweepstakes Automatic Entry Opt Out</u>: If you wish to take the above action without being entered into the Sweepstakes, you may hand print your full name, street address, (no P.O. Boxes), phone number, email address (be sure to use the one connected to your Smash Pass™), and Smash Pass™ number and request to be excluded from the Sweepstakes on a 3" x 5" piece of paper and mail it in an envelope with proper postage to "Smashburger Smash Pass™ Sweepstakes – **OPT-OUT REQUEST**," P.O. b. Mail-In Alternate Method of Entry: You must become a SmashClub™ member to enter. Membership is free. During the Promotion Period, to enter without making a purchase, hand print your full name, street address, (no P.O. Boxes), SmashClub™ cellular phone number (if any), SmashClub™ email address, and date of birth on a 3" x 5" piece of paper and mail it in an envelope with proper postage to "Smashburger Smash Pass™ Sweepstakes – Sweeps Entry," P.O. Box 5021, Dept. 838532, Kalamazoo, MI 49003-5021. You will receive 1 entry into the Sweepstakes, up to the limit stated below. Limit: 1 entry per stamped envelope. All mail-in entries must be handwritten, postmarked by February 15, 2019 and received by

February 22, 2019. All entries become the exclusive property of Sponsor and none will be acknowledged or returned. Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible, illegible, misdirected or postage-due entries, which will be disqualified.

<u>Limit</u>: 1 Sweepstakes entry per person per day during the Promotion Period, regardless of method or combination of methods of entry. Multiple entrants are not permitted to share the same Smash Pass™ or email address. Any attempt by any entrant to obtain more than 1 entry per day by using multiple/different email addresses, Smash Passes™, identities, registrations or logins, or any other methods will void that entrant's entries and that entrant may be disqualified from the Sweepstakes. Any use of robotic, repetitive, automatic, programmed or similar entry methods or agents (including, but not limited to, sweepstakes entry services) will void all entries by that entrant. In the event of a dispute as to any online entry, the authorized account holder of the email address associated with the Account used to enter will be deemed to be the entrant. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Potential winner may be required to show proof of being the authorized account holder.

- **Orawing:** Administrator is an independent judging organization whose decisions as to the selection of the potential winner are final and binding. On or about February 25, 2019, Administrator will select the name of the potential winner in a random drawing of all eligible entries received during the Promotion Period. The potential winner will be notified by email. The odds of winning the prize depend on the number of eligible entries received during the Promotion Period.

Winner and guest must travel on same itinerary. Winner must complete the trip within 1 year from the drawing date or prize will be forfeited. Any attempt by any person to undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil law, and, should such an attempt be made, the Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. Release and Limitations of Liability: Except where prohibited, by participating in the Sweepstakes, entrants agree to release and hold harmless Smashburger Servicing LLC, The Coca-Cola Company, Coca-Cola bottlers, HelloWorld, Inc., and their respective parents, subsidiaries, affiliates, promotional partners, prize partners, agents and agencies, and the officers, directors and employees of them (the "Released Parties") from and against any claim or cause of action arising out of participation in the Sweepstakes or receipt or use of any prize, including, but not limited to: (a) unauthorized human intervention in the Sweepstakes; (b) technical errors related to computers, servers, providers, printers or telephone or network lines; (c) printing errors; (d) errors in the administration of the Sweepstakes or the processing of entries; (e) late, lost, or undeliverable mail: or (f) injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Sweepstakes or receipt of any prize. Entrant further agrees that in any cause of action, the Released Parties' liability will be limited to the cost of entering and participating in the Sweepstakes and in no event shall the Released Parties be liable for attorney's fees. Disputes: Entrant agrees that: (a) any and all disputes, claims and causes of action arising out of or connected with this Sweepstakes or any prizes awarded shall be resolved individually, without resort to any form of class action, and exclusively by the United States District Court for the Eastern District of Michigan (Southern Division) or the appropriate Michigan State Court located in Oakland County, Michigan; and (b) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering any Sweepstakes, but in no event attorneys' fees.
