## Six Flags and Regal Halloween Program – Combo and VIP Grand Prize

## Official Rules

## NO PURCHASE REQUIRED TO ENTER OR WIN. VOID WHERE PROHIBITED

- 1. Eligibility: The Six Flags + Regal Halloween Program Combo + VIP Grand Prize (the "Sweepstakes") is open only to legal residents of the 50 U.S. (or D.C.) who are 18 years of age or older at the time of entry and who have an RCC membership with a valid email address and/or phone number associated with the membership before participating. If you are over 18 yet still a minor in your state of residence, you must have the permission and consent of your parent/legal guardian to participate in this Sweepstakes. - **5. How to Enter:** There are 3 ways to enter. You will need an RCC membership to enter via any method, membership is free. See limit below:
  - a) RCC Membership and Qualifying Purchase Method of Entry: You must have a Regal Crown Club ("RCC") card, which is free, to participate via this method. During the Promotion Period, purchase a combo that includes any size Fanta Scary Cherry or other frozen beverage and any size fresh popcorn in the same transaction with an RCC card in a single transaction (a "Qualifying Purchase") at participating Regal cinemas. During the Promotion Period, swipe or scan your RCC card or provide or enter your RCC card number when making a Qualifying Purchase at any participating Regal cinema and you will automatically receive 1 entry into the Sweepstakes. If you are making more than one Qualifying Purchase and want to earn additional entries for doing so, you will need to make the purchases in separate transactions. The "authorized account holder" of the RCC membership used at the time of ticket purchase will be deemed to be the entrant, subject to the eligibility restrictions herein. Potential winner may be required to show proof of being the authorized account holder.

- b) Regal Crown Club Reward Center: Eligible Regal Crown Club members who are participating in the Regal Crown Club program may enter the Sweepstakes via the Regal Crown Club Reward Center. To enter, login to http://www.MyRegal.com and click "Redeem Credits" during the Promotion Period. Then, click the "Filter" button and select "Sweepstakes" under "Category." Click the Six Flags + Regal Halloween Program Combo + VIP Grand Prize sweepstakes tile, review the "Reward Details" and other applicable terms and conditions, and indicate your (i) agreement to these Official Rules by checking the appropriate box and (ii) desired quantity of entries (see total limit below). Finally, click "Enter Sweepstakes." The authorized account holder of the Regal Crown Club card number used to login will be deemed the entrant and will receive one (1) entry into the Sweepstakes for each 100 Regal Crown Club credits redeemed at the Regal Crown Club Reward Center, subject to the eligibility restrictions above and the limit below. Potential winner may be required to show proof of being the authorized account holder.
- C) Free Mail-In Alternate Method of Entry: During the Promotion Period, to enter without making a purchase, using a Regal Crown Club card, or redeeming any credits via the Regal Crown Club Reward Center, hand print your full name, street address, (no P.O. Boxes), day/evening/cellular phone number (if any), email address and date of birth on a 3" x 5" piece of paper and mail it in an envelope with proper postage to "Six Flags + Regal Halloween Program Combo + VIP Grand Prize Sweepstakes Free Entry" P.O. Box 5025, Department 842229, Kalamazoo, MI 49003-5025. You will receive 1 entry into the Sweepstakes, subject to the eligibility restrictions herein and the limit below. Limit: 1 entry per stamped envelope. All mail-in entries must be handwritten, postmarked by November 1, 2019 and received by November 8, 2019. All entries become the exclusive property of Sponsor and none will be acknowledged or returned. Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible, illegible, misdirected or postage-due entries, which will be disqualified. The person whose information is set forth on such piece of paper and submitted by mail in accordance with this Section 5(b) will be deemed the entrant.

<u>Limit</u>: Up to 20 Sweepstakes entries per person during the Promotion Period, regardless of method or combination of methods of entry. Multiple entrants are not permitted to share the same email address or RCC card number. Any attempt by any entrant to obtain more than the stated number of entries by using multiple/different email addresses, identities, RCC cards, registrations or logins, or any other methods will void that entrant's entries and that entrant may be disqualified from the Sweepstakes. Any use of robotic, repetitive, automatic, programmed or similar entry methods or agents (including, but not limited to, sweepstakes entry services) will void all entries by that entrant.

- 6. Drawing: Administrator is an independent judging organization whose decisions as to the selection of the potential winner are final and binding. On or about November 12, 2019, Administrator will select the name of the potential winner in a random drawing of all eligible entries received during the Promotion Period. The potential winner will be notified by email, mail, or phone. It is entrant's responsibility to ensure that entrant's contact information submitted during registration or entry or contained in such entrant's RCC account is current and accurate. Sponsor will determine airline and flight itinerary in its sole discretion. No refund or compensation will be made in the event of the cancellation or delay of any flight. - **9. Publicity:** Except where prohibited, participation in the Sweepstakes constitutes entrant's (or, if entrant is a minor in entrant's state of residence, entrant's parent's or legal guardian's) consent for Sponsor and its designees to use entrant's name, likeness, prize information, city and state of residence, video, and voice and any comments, testimonials or other feedback related to any prize or Sweepstakes experience, whether written or oral, for promotional purposes in any media without further consideration.
- 10. General Conditions: In the event that the operation, security, or administration of the Sweepstakes is impaired in any way for any reason, including, but, not limited to, fraud, virus or other technical problem, the Sponsor may, in its sole discretion, either: (a) suspend the Sweepstakes to address the impairment and then resume the Sweepstakes in a manner that best conforms to the spirit of

these Official Rules; or (b) cancel the Sweepstakes and award the prizes in a random drawing from among all eligible entries received up to the time of the impairment. The Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of the Official Rules of this or any other promotion, or in an unsportsmanlike or disruptive manner. Any attempt by any person to undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil law, and, should such an attempt be made, the Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. The Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

Release and Limitations of Liability: Except where prohibited, by participating in the Sweepstakes, entrant (or, if entrant is a minor in entrant's state of residence, entrant's parent or legal guardian) agrees to release and hold harmless The Coca-Cola Company, Coca-Cola bottlers, Regal, Six Flags Entertainment Corporation, HelloWorld, Inc., and their respective parents, subsidiaries, affiliates, promotional partners, prize partners, agents and agencies, and their respective officers, directors and employees (the "Released Parties") from and against any claim or cause of action arising out of participation in the Sweepstakes or receipt or use of any prize, including, but not limited to: (a) unauthorized human intervention in the Sweepstakes; (b) technical errors related to computers, servers, providers, printers or telephone or network lines; (c) printing errors; (d) errors in the administration of the Sweepstakes or the processing of entries; (e) late, lost, or undeliverable mail; (f) any defect in a prize or inability to participate in the Sweepstakes or use a prize; or (q) injury, death, illness or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Sweepstakes, receipt, acceptance, delivery, possession, use or misuse of any prize, or any prize. Without limiting the generality of the foregoing, entrants agree that Released Parties: (A) have neither made nor will be in any manner responsible or liable for any warranty, representation or guarantee, express or implied, in fact or in law, in connection with the Sweepstakes and/or with respect to the prizes, including, without limitation, to any prize's quality or fitness for a particular purpose; (B) maintain no control over the personnel, equipment or operation of any air, water or surface carrier, bus or limousine company, transportation company, hotel, manufacturer or other person or entity furnishing services, products or accommodations ("Suppliers") as a part of the prizes provided in connection with the Sweepstakes; and (C) will not be responsible or liable for any injury, damage, loss, expense, accident, delay, inconvenience or other irregularity that may be caused or contributed to: (1) by the wrongful, negligent or unauthorized act or omission on the part of the Suppliers or any of their agents, servants, employees or independent contractors, (2) by any defect in or failure of any vehicle, equipment, instrumentality, service or product that is owned, operated, furnished or otherwise used by any of those Suppliers, (3) by the wrongful, negligent or unauthorized act or omission on the part of any other person or entity not an employee of the Released Parties, and (4) by any cause, condition or event whatsoever beyond the control of the

Released Parties. By entering the Sweepstakes, you hereby represent and warrant that you have read these Official Rules and are fully familiar with their contents.

- **Disputes:** Entrant (or, if entrant is a minor in entrant's state of residence, entrant's parent or legal guardian) agrees that: (a) any and all disputes, claims and causes of action arising out of or connected with this Sweepstakes or any prizes awarded shall be resolved individually, without resort to any form of class action, and exclusively by the United States District Court for the Eastern District of Michigan (Southern Division) or the appropriate Michigan State Court located in Oakland County, Michigan; and (b) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering the Sweepstakes, but in no event attorneys' fees.
