Coca-Cola 600 Family Pit Stop

Official Rules

NO PURCHASE REQUIRED TO ENTER OR WIN.

- 1. Eligibility: Coca-Cola 600 Family Pit Stop (the "Sweepstakes") is open only to legal residents of the 50 United States (or the District of Columbia) who are 18 years of age or older at the time of entry. If you do not have an Account, visit www.twitter.com to create Accounts free. Twitter's Terms are of Service (http://twitter.com/tos). Once logged into your Account, follow the links and instructions to become a follower of @CocaColaRacing. Then, Tweet with Twitter and include #CokePitStop. You automatically will receive 1 entry into the Sweepstakes drawing for the applicable Entry Period and 1 entry into the Sweepstakes drawing for the Grand Prize.

If you post updates to or receive updates from twitter.com via your wireless phone, message and data rates apply. Please consult your wireless-service provider regarding its message and data pricing plans.

<u>Limit</u>: 1 Sweepstakes entry per person per Entry Period, and up to 8 Sweepstakes entries per person into the drawing for the Grand Prize. Multiple

participants are not permitted to share the same email address or Account.
