Official Rules

- 1. You automatically will receive one (1) entry into the Sweepstakes.
 - b. Mail-in Alternate Method: To enter without downloading the App, hand print your name, address, day and evening phone numbers, email address (if any), and date of birth on a 3" x 5" piece of paper and mail it in an envelope with proper postage to "The \$50,000Closer to Home Sweepstakes," c/o ePrize, Inc., P.O. The potential winner may be required to show proof of being the authorized account holder.

Sponsor reserves the right, in its sole discretion, to disqualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of the Official Rules of this or any other promotion or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law.
