## Xbox One Ride and Win Promotion Official Rules

## NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

- 1. Eligibility: Xbox One Ride and Win Promotion (the "Promotion") is open only to legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years old, are in the Midtown Manhattan region of New York, NY during the Promotion Period, and who did not purchase any equipment to participate. - **3. Timing:** The Promotion begins on January 30, 2014 at 7:00 p.m. Eastern Time ("ET"), ends on February 1, 2014 at 11:00 p.m. ET (the "Promotion Period"), and is only available each evening from 7:00 p.m. ET through 11:00 p.m. ET.
- **4. Location**: You must be in the Midtown Manhattan Area, defined as any location from Houston Street through 42<sup>nd</sup> Street.
- **5.** The Offer: Receive a Free Ride through the Uber App (the "Application"): If you are in the Midtown Manhattan Area (as defined above) and you use the Application to request a free ride in an Xbox Truck, the Application will advise you about the availability and timing of an Xbox Truck. The availability of this special Xbox Truck is limited, and, due to consumer demand, your request may not be met during the Promotion Period.

Upon arrival of the Xbox Truck, You will be able to designate a destination (at no cost) anywhere within the Midtown Manhattan Area so long as the ride does not exceed twenty (20) minutes. <u>FORTY-FIVE (45) FOURTH PRIZES</u>: A \$50 NFLShop.com gift card. Terms and conditions of gift card apply. ARV: \$50. Odds of winning are approximately 1:11.

THIRTY (30) FIFTH PRIZES: A 3-month Xbox Music Pass. ARV: \$29.99. Odds of winning are approximately 1:17.

ONE HUNDRED (100) SIXTH PRIZES: An Xbox kit including: beanie, scarf, chap-stick and tote bag. ARV: \$25. Odds of winning are approximately 1:5.

ONE HUNDRED EIGHTY (180) SEVENTH PRIZES: An Xbox hat. ARV: \$15. Odds of winning are approximately 1:3.

For All Electronic Prizes: The actual value of electronic prizes is subject to price fluctuations in the consumer marketplace based on, among other things, any gap in time between the date the ARV is estimated for purposes of these Official Rules and the date the prize is awarded or redeemed.
