b. Enter without using Bing Rewards Credits: If you do not already have an Account, visit www.bing.com/rewards and follow the links and instructions to create an Account. Promotional gift card expiration dates will be provided upon delivery. Winner must REDEEM and SPEND the Microsoft Promotional Gift card or code according to the terms and conditions and the expiration dates that are provided. ARV: \$500.
