## Ulta BeautyFest Sweepstakes Official Rules

## NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

- 1. Eligibility: The Ulta BeautyFest Sweepstakes (the "Sweepstakes") is open only to legal residents of the fifty (50) United States and District of Columbia who are at least eighteen (18) years old at the time of entry. Twitter/Instagram's servers are the official time-keeping devices for the Sweepstakes.

**4. How to Enter:** To participate, you will need to have a Twitter and/or Instagram account (each a "Social Account"). Creating each Social Account is free but is subject to the applicable terms and conditions: <a href="http://twitter.com/tos">http://twitter.com/tos</a> or <a href="https://help.instagram.com/478745558852511/">https://help.instagram.com/478745558852511/</a>. **Posting on Instagram requires a mobile device and therefore message and data rates may apply.** If entering via a mobile device and using your wireless carrier's network, standard data charges from your wireless carrier may apply. Your account settings on the Social Account you use to enter must be set to "unprotected" and/or "public" in order for your Tweets and Posts to be viewable by Sponsor. b. <u>Via Twitter</u>: Take all of the following actions: (i) at a participating ULTA store, take a photo of the Ulta BeautyFest floor decal ("Photo"); and (ii) Tweet the Photo **and** the hashtags #ultabeautyfest **and** #sweepstakes **within the original Tweet.** 

ReTweets will **not** be deemed entries.

Your Tweet/Instagram post and its included content will hereafter be referred to as your Submission. Your Submission must be your original work. If you include the names or likenesses of other individuals, you must have their permission to be included and to grant the rights set forth in Section 5. Minors may not be included in the Submission. If requested, you must be able to provide such permissions in a form acceptable to Sponsor. Your Submission need not include any reference, positive or negative, to Sponsor's products or services. Your Submission must comply with the Official Rules and the following Submission Restrictions.

## **Submission Restrictions:**

You automatically will receive one (1) entry into the applicable Entry Period drawing and the Grand Prize drawing for your qualified Submission. Sponsor reserves the right to disqualify any Submission that it finds unlawful, or in violation of these Official Rules, all in its sole discretion.

Released Parties (as defined in Section 8, below) are not responsible for lost, late, unreceived, damaged, incomplete, invalid, un-intelligible, garbled, delayed or misdirected Submissions or failure to receive Submissions due to limitation of third-party social network platforms all of which will be void.

<u>Limit</u>: You may enter up to five (5) times per Daily Entry Period during the Promotion Period, regardless of method of entry. Multiple entrants are not permitted to share the same Social Account Any attempt by any entrant to obtain more than the stated number of entries by using multiple/different Social Accounts, identities, registrations and logins, or any other methods will void that entrant's entries and that entrant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. In the event of a dispute as to any registration, the authorized account holder of the Social Account used to register will be deemed to be the entrant. - **5. If requested, entrant will sign any documentation that may be required for Sponsor or its designees to make use of the non-exclusive rights entrant is granting to use the Submission.

Sponsor will randomly select the potential First Prize winners from all eligible entries received during each applicable Entry Period on or about the dates listed in Section 3 above. Nonwinning entries will **not** be included in the subsequent Daily Entry Period drawing. Sponsor will randomly select the potential Grand Prize winner from all eligible entries received during the Grand Prize Entry Period on or about November 18, 2019. Each potential winner will be notified by Sponsor (@ultabeauty) via the social platform he/she used to enter the Sweepstakes and will be required to provide his/her name, mailing address, date of birth, phone number and email address to confirm eligibility and for prize fulfillment purposes within twenty-four (24) hours of the date notice or attempted notice is sent into order to claim his/her prize. Each potential winner (or parent/legal guardian if winner is a minor in his/her state of residence) will also be required to sign and return a Declaration of Compliance, Liability Waiver and, where not prohibited, a Publicity Release ("Declaration") which must be received by Administrator, within five (5) days of the date notice or attempted notice is sent, in order to claim his/her prize. If a potential winner of any prize cannot be contacted, fails to sign and return the Declaration or provide any other requested information, within the required time period, or the prize is returned as undeliverable, the potential winner is disqualified and forfeits his/her prize. individually, without resort to any form of class action, and exclusively by the United States District Court for the Eastern District of Michigan (Southern Division) or the appropriate Michigan State Court located in Oakland County, Michigan; (2) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Sweepstakes, but in no event attorneys' fees; and (3) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim, indirect, punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased.
