## Holiday Beauty Blitz Challenge Official Rules

**1. **4. How to Enter:** To participate you must have an Instagram account. Creating an account is free but is subject to Instagram's terms: http://instagram.com/about/legal/terms/#. Your account settings must be set to "unprotected" and/or "public" in order for Sponsor to view your comments. Posting on Instagram requires a mobile device and therefore message and data rates may apply. Please consult your wireless-service provider regarding its pricing plans.

During each Giveaway Period, sponsor will host a short program on Instagram Live where it promotes its Beauty Blitz offers for the upcoming week ("Live Event"). After you watch this Live Event, locate Sponsor's "Holiday Beauty Blitz" Instagram post (posted at approximately 12:00 p.m. CT) post a comment about at least one product promoted in the Instagram Live event. <u>Other Entry Requirements:</u> Multiple entrants are not permitted to share the same Instagram account. Any attempt by any entrant to obtain entries by using multiple/different Instagram accounts, identities, registrations and logins, or any other methods will void that entrant's entries and that entrant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. **5. **6. Each potential winner will be notified by @UltaBeauty and will be required to provide his/her name, mailing address and date of birth to confirm eligibility and for prize fulfillment purposes within 24 hours of the date notice or attempted notice is sent into order to claim the prize. Sponsor will determine which products, their features, including for example color and size, in its discretion. ARV: will vary for each Giveaway period but will range from approximately \$300-400.

Prizes are non-transferable and no substitution will be made except as provided herein at the Sponsor's sole discretion. Sponsor reserves the right to substitute a prize for one of equal or greater value if the designated prize should become unavailable for any reason. Winners are responsible for all taxes and fees associated with prize receipt and/or use. Odds of winning a prize depend on the number of eligible entries received during the Promotion Period. Limit: One (1) prize per person. Prizes will be fulfilled approximately 8-10 weeks after the conclusion of the Sweepstakes.
